- 1948.03 • Founded as Kokutetsu Sekiyu Niatsukai K.K. in Chuo-ku Tokyo.
- 1948.06 • Renamed as "Sekiyu Niyaku K.K."
- 1949.03 • Deployed first tank truck (3,500L). Commenced petroleum transport operations.
- 1949.04 • Commenced operations at the company's first oil depot.
- 1958.12 • Niyac Labor Union established.
- 1959.05 • Founded Kanto Kosan K.K.(currently Niyac Trading Inc.).
- 1960.11 • Deployed first stainless steel tank trucks. Commenced chemical transport operations.

- 1970.04 • Founded Nihon Chemical Yuso K.K.(merged into Niyac Corporation in 2008).
- 1973.11 • Deployed 2,001st tank truck.
- 1974.09 • Founded West-Japan Niyac Corporation (later became Kyushu Niyac K.K. ,then merged into Niyac Corporation in 2011).

- 1978.04 • Founded Sekiyu Bosai Co. Ltd.
- 1985.07 • Founded Nicom Corporation (currently Niyac System Support Co. Ltd.).

- 1991.10 • Commenced NVOCC operations.
- 1992.04 • Commenced high pressure gas transport operations.
- 1996.12 • Relocated head office to Shiba-Daimon Minato-ku Tokyo.
- 1998.02 • Commenced LNG transport operations.
- 2000.09 • Acquired Aichiken Sekiyu Unyu K.K.(later became Aiseki K.K. ,then merged into Niyac Corporation in 2016).
- 2002.07 • Launched BUSS (Bulk Haul Management Support System).
- 2003.07 • Acquired Kowa Transportation Co.Ltd.
- 2004.06 • Founded Yugen Kaisha Hokuriku Sekiyu Butsureyu.
